RULES & FEES

INTRODUCTION:

The season at GICC begins mid May and extends until Canadian Thanksgiving. The Club's facilities are available for rent to members. Since the Club Board is responsible for the Professional and Course staff, Members or Guests should not reprimand or discipline employees. If you have a problem, contact the related committee chairman or any board member. The Club does not accept responsibility for, nor does its insurance cover, loss or damage to golf clubs or personal property.

MEMBERSHIP:

To become a member of GICC, you must be sponsored by two (2) members of five (5) years standing. The application can be downloaded off our website. The application is given to the Membership Committee for review and then presented to the Board of Directors for approval. Parents, children and blood siblings of members rise to the top of the waiting list. To become a Social Member, it is necessary to be a Regular Member for fifteen (15) years before applying.

Limit 6 rounds of golf per year per family. Limit 3 guests per round.
Tournament play allowed if there are openings available.

INITIATION FEES

Initiation fee is **\$5,500 CDN + HST.**
(\$6215 Cdn including HST)

PAYMENT OPTIONS:

- Dues are issued in March and are payable in full with the **due date being June 1st**
- Payment can be made by **cheque or credit card.**
- Credit cards on file will be charged June 1st
- No fees are charged for payment by credit card
- For any payment inquiries please contact the club office: 613-923-5511

PAYMENT OF MONTHLY ACCOUNTS:

The Club's books close on the last day of each month and Members should receive their bills by the 10th. Members may request billing by email. These bills are due when rendered. Payments by mail are to be sent to **GICC, PO Box 215, Gananoque, Ont. K7G 2T7.** The Credit Card Authorization Form can be downloaded from our website. Any GICC Monthly charges not received within 30 days of the statement date will be subject to interest at an annual rate of 24%.

NOTES:

- Your GICC charges will be applied to your credit card information on file 30 DAYS from the date of your invoice/statement. Once you have decided to put your credit card on file for payment **going forward all payments will be paid by credit card only.**
- Club storage dues will be invoiced after June.

“TEE-ON” ACCOUNTING, BILLING AND INVENTORY:

During the 2020 season GICC began using the TeeOn software system to record inventory for the club, and to record purchases that our members make.

- **Every member of GICC has a TeeOn account.** Members of the same household have their accounts joined together as a Family account and all purchases made are kept in the Family account.
- Items for sale at GICC like merchandise, food, drinks, green fees, cart rentals, and memberships are all part of the Tee-On system. **When a member makes a purchase of an item, the sale of the item is recorded in the member or Family account.**
- At the beginning of each month our accountants send out invoices through the Tee-On system to the email that is on file in your individual or Family account. The response from our membership has been quite positive. Members seem to appreciate being able to look at their invoice and have details of what they purchased as well as when the purchase was made. In other words, the invoice produced is detailed and this seems to be well received by our members. Members can also ask our coordinators for a receipt at the time a purchase is being made. Our accountants then manage your payments made on your accounts on the Tee-On system.
- Members, who have established a Tee-on login password can access their accounts online. If you need help logging into Tee-on or have not yet established a login password, you may contact the coordinator for assistance.
- **Canadian members can pay their invoices in 3 ways:**

- **U.S/International members can pay their invoices in 2 ways:**

 - Using a credit card on file with our accountants Losee and associates at 613-766-6323

RESIGNATION:

Members wishing to resign shall give WRITTEN NOTICE to the Secretary. IF NOTICE IS NOT RECEIVED BY MAY 1st, THE FEE FOR THE CURRENT YEAR MUST BE PAID BEFORE RESIGNATION IS RECOGNIZED.

MEMBER CONDUCT RULES:

- No member may threaten another person or display inappropriate conduct or language on Club property
- Members shall not reprimand staff or other members. Members having complaints shall report them to the President the Clubhouse Manager or Clubhouse Assistant Manager
- Members are responsible for their guests' conduct while on Club property.
- Members and their guests are reminded that, as a condition of our liquor license, no outside alcohol may be brought onto the property and that liquor on the dock is also prohibited.
- The Board reserves the right to suspend or terminate any member's membership for breach of the club's Member Conduct Rules or for their conduct outside the club that, in the opinion of the board, would tend to bring the reputation of the club into disrepute and/or could have a detrimental effect on the well-being of the membership or staff.

GUESTS:

A Member is responsible for any damage or debt incurred by any guests he or she brings to the Club. A guest is governed by the same golf, tennis or bocce rules and attire standards which Members are governed by. Non-family/non-houseguests are limited to three invitations to the Club in any calendar year.

GOLF ATTIRE

Acceptable Golf Attire:

- Slacks, shorts, skirts or dresses of normal golf length
- Men's golf shirts must have collars and sleeves
- Women's golf shirts must have either sleeves and/or a collar
- Hats must be worn with brim forward

Unacceptable Golf Attire:

- Cargo pants/shorts
- Jeans, cutoffs, short shorts, tank/halter tops, track/sweat suits

GOLF AND GOLF CARTS

Only persons 18 years & older are permitted to drive the motorized carts. The cart occupancy is limited to two (2). Drive in a conservative and respectful manner to prevent injury and damage to the course or equipment. Please be mindful of the cart's speed and effective use of the brakes. Power and pull carts should be kept away from greens, tees, and traps. Please repair your ball marks, replace divots, and rake sand traps and leave rake outside the trap. Be mindful of other players on the course and conduct your play in a courteous, respectful, and safe manner.

All golfers, members, and guests are required to sign in with the coordinators prior to beginning their round. Handicaps are computed regularly, and updates are available through the coordinators. Score cards should be totaled, names written legibly & placed inside the clubhouse in the appropriate box.

On Tuesday mornings ladies are given priority access to the course and are encouraged to begin their rounds before 10:00 o'clock. Conventional use and access may resume after this time.

On Saturdays when there are club dinners, all players not registered for the dinner must be off the course by 5:00 PM and off the island by 5:15 PM. During special events or tournaments, members' use of the golf course may be restricted. In these situations, members wishing to play golf are asked to coordinate course scheduling with a coordinator prior to starting their game.

GOLF FEES

A member's guest pays a fee each time they play. Members sponsoring these guests are responsible for their fees and conduct. Members should play with their guests. If this is not practical for house guests, the member must call the club or send a note with the member's name and club number. Guests of regular golf members may leave their bags overnight if space permits.

Music on the Course:

Music at golf courses is a developing trend. At the same time, one of attractions of GICC is the ability to enjoy our unique river environment in relative tranquility.

Music will therefore be permitted at GICC on the following conditions:

- 1. music must only be audible to the members of your group
- 2. music should not be audible to any other groups.

Members are asked to use appropriate discretion to ensure that music is not audible where greens and tees are in close proximity to each other and are reminded that they are responsible for the conduct of their guests at all times.

TENNIS REGULATIONS

GICC has 2 Har-Tru tennis courts. Courts are available for reservation, except when the courts are in use for prearranged club tennis events. Courts may be reserved thru the coordinator for 1-hour periods for singles matches and 2-hour periods for doubles matches, commencing on the hour. After that time, courts may be rebooked providing no regular member seeks a court. Regular members may reserve courts 48 hours in advance; 24 hours in advance for social members. Reservations will be held for 15 minutes after the reserved time. For weekend play, only members 22 years and over may reserve courts in advance. Players under 22 may reserve courts 1 hour prior to play. One family may not book both courts. Please sign-up all players, including guests. If a court is not reserved, it may be used by members and their guests, but members have priority. Players are requested to brush the courts at the finish of their play. Courts will be closed during the Saturday Night Dinners.

WEEKEND DOUBLES PLAY:

Doubles tennis matches are offered by reservation only on Sat. and Sun mornings from 9:00 -11:00 for players USTA rated 3.5 and above, then from 11:00-1:00 for players USTA rated 3.0 and below. Reservations can be made on Clubster and become open to regular members at noon each Monday. Reservations for social members and guests open at noon on Thurs.

GUEST PROTOCOLS:

A fee for the guest of a member is paid each time the guest plays. Members sponsoring these guests are responsible for their fees. Members are expected to accompany their guests during play. If this is not practical, the member must call the Club or send a note with the member's name and club number. Members are responsible for the behavior and conduct of their guests while using the club facilities.

CLINICS:

On clinic days, if the instruction court is not booked for the next day by 2PM of the previous day, the court will then become available for regular reservation conditions. As posted on the bulletin board, additional private lessons may be booked by the member at a mutually agreeable time with the Pro. The member will reserve the court. Guests taking instruction will be expected to pay court fees. Clinics and camps are available to members & their guests in that order, arranged through the Pro.

PROFESSIONAL INSTRUCTION:

Tennis professional Tad Clark provides private and group instruction to members. Fees apply and are paid directly to Tad. Clinics and camps are scheduled and available to members and their guests. Private Lessons may be booked by the member at a mutually agreeable time with the Pro.

ATTIRE:

Players must wear proper tennis shoes for soft court play only. Basketball, running, or thong-type shoes are unacceptable. Players are expected to wear appropriate tennis clothes consisting of shirts and shorts or skirts; no tank-tops, halters, or jeans.

EQUIPMENT:

The coordinator has racquets for loan & tennis balls for purchase. A ball machine is available, but members are asked to schedule a brief instruction session with the Tennis Chairman before initial use.

BOCCE REGULATIONS

Members are encouraged to make good use of the two Bocce courts. The equipment may be obtained from the coordinator in the club house and during busier times of the season it might be wise to call ahead to ensure the courts are available. Respectful conduct and courtesy are required while using the facilities and equipment. Upon completing your matches, it is expected that your party will sweep the courts with the supplied brooms and should you be unfamiliar with this maintenance task, please ask for assistance from those “in the know”. In the same vein, you are responsible to return the material to the club coordinator and ensure it is in good order.

An annual season-end “Bocce & Bites” social and championship play will take place in August. It is hoped that more Bocce related activities and leagues will develop over the season to encourage more use and enjoyment of the Bocce facilities at the club. Please contact the Bocce committee through the Club Coordinator if interested in becoming more involved in the activity.

MEDICAL EMERGENCY

The coordinators are CPR certified and prepared to assist members in the event of a medical emergency. A defibrillator is located inside the ladies’ lounge, on a shelf in plain view from the common area of the club.

If you find yourself or someone in need of medical or first aid attention and you are in a remote area of the property, call the clubhouse at **(613) 923-5511** and the first aid equipment will be brought to you. **If you need critical care, call 911 immediately.**

GOLF COURSE AND/OR CLUBHOUSE RENTAL:

The golf course will be considered for rental by a “member organized group” during the months of May, June, September (after labor day) or October. For information, contact the Clubhouse Manager

FOOD AND BEVERAGES

In compliance with provincial licenses and insurance regulations, all alcoholic beverages consumed at GICC must be purchased through the Club. There are restricted locations in which alcohol is not permitted, as in the case of the docks. In the case of special events, the organizers will arrange to procure and distribute alcohol and food in compliance with the regulations and licenses governing GICC’s operation. Food items and non-alcoholic beverages are available through the coordinators on request. Please advise them well in advance so they have the opportunity to effectively prepare the food items among their other duties.

SATURDAY NIGHT DINNERS

Saturday night dinners play an integral role in promoting fellowship among our members. It may look like a lot of work to host a dinner, and in the past, it was, but we have re-engineered Saturday Night Dinners to lessen the Host's responsibilities in order to encourage broader participation and more varied menus or themes.

Gone are the days of having to cook the dinner and all by yourself, serve and clean up. We now encourage catered dinners, paid for by the Club, and we have staff to help serve and clean up. Now, the Host's job is to imagine the theme, order and deliver the food to the Club, decorate the dining room, and assist our staff to serve and help pick up after the dinner. Our paid staff will do all of the rest, including clean the kitchen and wash the tablecloths!

We encourage all members to gather some friends, dream up a theme and host a dinner ! If you are not on a dinner committee and wish to be, contact Marcy Robinson Dembs, Chair of the Dinner Committee or the Clubhouse Manager at coordinator@grenadiergolf.com.

Dinner Hosts will receive a communication from the chair of the Dinner Committee Chair in May with a more detailed timeline for hosting.

Basic Guidelines for Hosting a Saturday Night Dinner

The first step to hosting a dinner is to form a committee of 6 members and guests (or so) to help plan, order and deliver the food to the Club, decorate the dining room, assist with serving the meal and assist with cleaning up the dining room. Hosts are responsible to provide appetizers, dinner and dessert for 110 members and guests. Both Club Coordinators and two employed kitchen staff are assigned to the kitchen to assist the Host Committee each Saturday night. The entire cost of the dinner, including decorations, must be commensurate with the price of each dinner which is \$45.00 per member and \$15.00 per child between the ages of 6 and 12. Children 5 and under are free. Special dinners are \$50.00 per adult and \$20.00 per child as above. Feel free to check the freezer and refrigerator at the Club to see if there are items you could use as part of your dinner.

The Bar Committee and the Clubhouse Manager maintain a roster of Club members who are Smart Serve-certified and will assign bartenders for each dinner. In addition, a professional bartender will be hired for dinners with anticipated attendance of more than 110. The Host Committee is not responsible for the bar, unless they request a themed cocktail, for instance, to go with their dinner. In that case, the Host Committee must arrange with the Clubhouse Manager for the ingredients and the recipe to be available on the night of the dinner.

At least two weeks before each dinner, Hosts will want to order the dinners from their caterer and make final arrangements with the caterer.

At least two weeks before the dinner, Hosts will also be responsible to provide the Clubhouse Manager and the Dinner Committee Chair with the details specific to their dinner so that the dinner can be shared and promoted with the membership on Clubster. The description should include the theme of the dinner, the menu, and the names of the committee members, and any other tantalizing information you wish to include to promote your dinner.

The Club Manager will contact the Host by the Friday morning before the dinner to confirm the number of reservations.

In addition to transporting the dinners to the Club on the late afternoon of the dinner, the Host Committee is responsible for decorating the dining room. That is typically done on the Friday before or the Saturday of the dinner. Please check with the Club Manager to coordinate when the decorations will be put up. Some decorations are already available in storage at the Club from previous dinners. The green and white tablecloths are always available, as are small vases for centerpieces.

Within the week following the dinner, the Host is responsible to provide the Club Manager or the Diner Committee Chair with the budget for the dinner and copies of the receipts for the expenses to be reimbursed. It is not expected that the Host Committee pay for the dinner. Donations are welcome, but are not required or expected. What is expected is that you will have fun and enjoy contributing your time, energy and creativity to the Saturday Night Dinner Experience at GICC!

Other Saturday Night Dinner Considerations

Dinner Registration/Sign up: Sign-ups for each dinner will begin at noon of the Saturday prior to the dinner. The Club Coordinator will post notice of dinner and the sign-up announcement on Clubster and post a notice on the GICC Bulletin Board. The Club Coordinator will create a waiting list after the maximum number of reservations has been reached.

Cancellations: Members may cancel their dinner reservations until noon on the Thursday before the dinner without being charged for the dinners they reserved. If a member cancels after such time, and there is a waiting list, the Coordinator will call the names on the list in an attempt to fill the canceled reservation(s). If a canceled reservation is filled, the canceling member will not be charged for that reservation. If a member cancels their reservation after such time, and there is no waiting list, or the list has been exhausted so the canceled reservation is not filled, the canceling member will be charged for the dinners they have reserved and have not used.

Guests: Although we encourage Members to bring guests to experience our terrific club, we have limited space and need to ensure that all members who wish to attend a dinner, are able to secure a reservation. To that end, members may only reserve up to six reservations, including the member, per dinner. Requests for reservations for additional guests can be made to the Club Coordinator who will create a waiting list to be filled if the dinner is not sold out by noon on the Thursday preceding the dinner.

Bar Service: The Club's bar service is managed by the Bar Committee. Anyone serving alcoholic beverages at GICC must have a SMART SERVE Certificate to be in compliance with the law and our liquor license. Members are encouraged to acquire the Alcohol and Gaming Commission of Ontario (AGCO) recognized certification through the online course at the Smart Serve site (<https://smartserve.ca/online-training/>). Upon receiving certification, please notify the Clubhouse Manager so you can be added to the list of qualified servers. Thank you!
